**A STEAM ROLLER PASS GOOD ROADS BILL**

CLAIM MADE BY SOME OF THE LEGISLATORS THAT MACHINE IS BEING USED.

**BILLS PASSING RAPIDLY**

Many Measures of Miner Interests Are Put Through Both Branches in a Day—End of Session Now Not Far Off.

Minerark, N. D.—For the first time in the present session of the state legislature it is charged that the steam roller is being used to make the path of bills for passage smoother and to relegate to the table bills that are not wanted by the majority. This condition is alleged to have started on Thursday when the house had resolved itself into a committee of the whole and placed Representative Martin in the chair.

Mr. Martin was in control of the situation from the time he took the chair and some of the rulings are claimed to have been somewhat arbitrary.

A large number of bills were passed by the house, some by the yeas and nays, and some by a vote which will soon be known.

Another great number of bills were passed by the yeas and nays, the following being placed upon their reading:

H. B. No. 483—repeating action 25 yeas, 21 absent and not voting.

H. B. No. 416—Covering of canyons and feet of adjacent sections; auditors referred back to committee on ways and means.

H. B. No. 427—Compensation of public administrator; 75 yeas, 21 absent and not voting.

H. B. No. 219—Penalty for failure to comply with provisions of law relating to grain buyers' reports; 20 yeas, 24 yeas, 21 absent and not voting.

H. B. No. 234—Initiative and referendum. Made special order for Wednesday afternoon at 7 o'clock.

H. B. No. 235—Appropriation for rental of P. O. Hallmark's land; 27 yeas, 1 nay and 21 absent and not voting.

H. B. No. 250—Appropriation for Wisconsin station; passed 25 yeas and not voting.

H. B. No. 49—Appropriating \$112,000 for current and operation; passed 25 yeas and not voting.

H. B. No. 174—Appropriation for maintenance of agriculture; sub-appropriation for school for deaf and dumb at Devils Lake; 23 yeas, 2 yeas and 21 absent and not voting.

H. B. No. 175—Appropriation for school of science at Wahpeton; 23 yeas, 1 nay and 21 absent and not voting.

H. B. No. 200—Appropriation for mining station at Hettrick; 23 yeas, 1 nay and 21 absent and not voting.

H. B. No. 194—Appropriation for the maintenance of agriculture; sub-appropriation for school for deaf and dumb at Devils Lake; 23 yeas, 2 yeas and 21 absent and not voting.

H. B. No. 316—Relating to sidewalk special assessment; 70 yeas, 4 yeas and 21 absent and not voting.

H. B. No. 212—Assessment of bank stock; 25 yeas, 21 absent and not voting.

H. B. No. 177—Duty of county auditors and requirements of issue and deeds; 23 yeas, 3 yeas and 21 absent and not voting.

H. B. No. 92—Anti-cigarette bill; 63 yeas, 2 yeas and 21 absent and not voting.

Speaker Signs Bills.

The speaker signed the following bills: R. R. Nos. 49, 59, 141, 150, 73 and 12.

At this juncture house bills Nos. 28 and 291 were returned from the senate to the house.

S. B. Nos. 174, 244, and 251 were placed on their first and second readings and referred to the various committees.

Third Reading Senate Bills.

S. B. No. 235—Creating state board of education. Passed.

R. B. No. 231, relating to building and loan associations and regarding the renouncing of the charter. Passed.

S. B. No. 236, regarding the district second-hand goods, before they are offered for sale. Passed.

R. B. No. 211, relating to a maximum rate for transportation of briquettes. Put over one day to allow members to secure information.

S. B. No. 210, relating to the storage of unclaimed goods. Providing that railroads must hold unclaimed goods thirty days instead of twenty and then store them in nearest bonded warehouse instead of sending them to Grand Forks. Passed.

Memorial Joint Session.

As members of the legislature were in session before the Saturday afternoon session of the senate, a house and senate was held for the late Judge Justice Morgan of the supreme court and for Judge Templeton of the district court. The programme was opened by prayer and Rev. Mr. Harris followed by an instrumental solo by Miss Helen Plank and a selection by a male quartet.

Those speaking of the late Judge Morgan were Judge Ellsworth, former justice of the supreme court, for the supreme court, for the district court, and Tracy R. Bangs for the bar.

Those speaking of Judge Templeton were Durlough F. Spaulding, chief justice of the supreme court, and Hon. Tracy R. Bangs, delivered the memorial for the bar. The exercises were closed with singing of America by the audience.

The members of the legislature went to Grand Forks on Saturday afternoon to attend a performance prepared by the inmates of the reform school.

At 4:30 p. m. the ordinary to mark the session of Friday afternoon, nevertheless, the routine business represented the confirmation and disposal of a great deal of important legislation.

A bill was passed. The house failed to reach the order of business including the passage of the bill for the confirmation of general orders, and with respect to these two matters the legislature adjourned on Friday night with a calendar of some length.

**PASS GOOD ROADS BILL**

**BILLS PASSING RAPIDLY**

Minerark, N. D.—Wednesday was a busy day in the house.

The house convened at 2 o'clock. Representative Colton apologized for Tuesday's unpleasant features occasioned by the remarks.

The apology is accepted by Representative Hendrickson, and the house congratulated itself that another storm had safely passed.

The good roads bill, once turned down, is reviewed and passed by the house.

The passage of many bills represented the work of a long routine session.

Protest is made against Hillyary's motion for a recess in connection with a resolution adopted.

Representative Williams sought protection for North Dakota's coal fields.

The house adjourned at 5:30 o'clock.

The house Wednesday afternoon demonstrated that it is possible to resolve upon a measure after it has been introduced and passed the action by which it was lost. In other words, the house can pass a measure which it has already rejected.

The bill which was employed for this purpose is a bill for a parliamentary procedure, was certain bill No. 411, providing state aid for good roads. The measure failed to pass on its first reading, and upon motion to pass the bill, the speaker was called in and the house was adjourned until Wednesday afternoon.

The house resolved itself into a committee of the whole, with Representative Watt of Cass, chairman, purely in order to consider the measure intended for passage, and the committee agreed and reported. The bill was then placed upon its second reading, and passed, and in spite of the protest of Representative Burnett and others who have been heard in connection with the measure, it was passed by a vote of 40 yeas and 14 absent and not voting.

No important resolutions were introduced in the house yesterday afternoon, as planned, because Representatives of the various counties are in possession of their own areas of a point of personal privilege, declaring that inasmuch as he regarded that he had a right to speak, he would do so.

House Bills Passed.

The following house bills were placed upon their third and final readings, and without exception, passed without serious contest:

No. 24, prescribing the manner in which the right of eminent domain may be exercised for public use; passed with 21 yeas, 12 yeas and 21 absent and not voting; cinchbar applied.

No. 178, appropriating money for the maintenance and protection of the Military Wood reservation in Ramsey county; passed with 23 yeas, 3 yeas and 21 absent and not voting.

No. 31, appropriation for Dickinson experiment station; passed with 26 yeas, no yeas and 21 absent and not voting.

No. 20, authorizing private associations to work under the laws and by the roads at their own expense; passed by 23 yeas, 1 nay and 21 absent and not voting.

No. 34, relief for Co. L, First regiment, N. D., G. training school; passed by 23 yeas, 12 yeas and 21 absent and not voting.

No. 318, rates for state officers in the public service; referred to committee.

No. 16, salaries of deputy sheriffs; passed with 23 yeas, 12 yeas and 21 absent and not voting.

No. 41, notice of foreclosure; passed with 21 yeas, 12 yeas and 21 absent and not voting.

No. 416, relating to the percentage of taxes; passed by 50 yeas, no yeas and 21 absent and not voting.

No. 415, relating to the same; passed by 23 yeas, 2 yeas and 21 absent and not voting.

No. 119, authorizing court or judges to remove certain officers from office; passed by 21 yeas, 5 yeas and 21 absent and not voting.

No. 39, abolishing expense of selling lands or lots for tax; passed by 23 yeas, 2 yeas and 21 absent and not voting, providing for the proper identification of persons charged with commission of public offenses; passed by vote of 27 yeas, 12 yeas and 21 absent and not voting.

After the adjournment proceedings, and payment of expenses incurred, passed by a vote of 39 yeas, 5 yeas and 17 absent and not voting.

Senate convened at 1 o'clock.

After a recess of ten minutes, it was announced that the senate approved board of control appointments with the exception of A. D. Grant of Jamestown.

Only a few new bills were introduced.

Appropriation committees given month time to prepare report.

Extremes in session at St. Paul sent a message to the house, protesting against passage of Owen's bill in the house.

Gibbins' bill petition asking for a master of water demurrage; passed by vote of 23 yeas, 12 yeas and 21 absent and not voting.

Only a few bills are reported back by committees.

Senate adjourned at 4:40.

The state senate finally disposed of the matter of confirming the board of control appointments, by affirming the appointments of R. S. Lewis of Fargo and J. W. Jackson of Jamestown, but refused to confirm the appointment of A. D. Grant of Jamestown.
