Brief Mention of What is Transpiring in Various Sections of Our Own and Foreign Countries

WASHINGTON

The house ethics committee made preliminary arrangements for taking testimony in the field in the Michigan and Colorado strike investigations.

Secretary Daniels told the house ethics committee the government should develop its own oil supplies for battleships. It favored a \$500,000 appropriation for locating and developing an oil field.

Colonel William C. Gorgas, the man who drove disease out of Panama canal zone has been honored by the senate as surgeon of the army to succeed the late Gen. George H. Torney.

Cooperation by farmers in killing of the chinch bug, a pest which, it is estimated, has done \$10,000,000 worth of damage to crops in this country during the past sixteen years, is recommended by the department of agriculture.

Arbitration of all questions involving those involving national honor, is proposed in a treaty, the terms of which were agreed upon by Secretary Bryan and Constantino Brum, the Italian minister. It is expected the new treaty will be signed in the near future.

Nonwails of sixteen general arbitration treaties with foreign nations were considered by the senate without action and will be again discussed. President Wilson has urged that all the treaties be ratified by the senate as soon as possible.

Requests have been mailed from the treasury department to national banks and state banks and trust companies which have signified their intention to join the federal reserve banking system asking for indication of preference as to the location of the reserve banks to serve their districts.

In deciding not to recommend to the president the withdrawal from entry of large areas of lands in Colorado and Utah containing deposits of uranium, Secretary Lane announced his belief that private enterprise should be unhampered in finding a way for developing these resources.

Senator Shaffroth of Colorado is presenting the senate judiciary committee for favorable action on his resolution to amend the constitution so as to make the date of the convening of congress the first Monday in January instead of March 4, and to have the term of the president begin the third Monday in Jan. instead of March 4.

The battleships Virginia, Rhode Island, Nebraska and Georgia have moved from Vera Cruz to Tampico, and the battleships Connecticut and Kansas have moved to Vera Cruz. Rear Admiral Fletcher commanding the squadron, made no comment regarding the charges in the navy department, and officials say they were without significance.

Before the house commerce committee Louis D. Brandeis, discussing the interstate trade commission bill, declared for a uniform system of accounting for the corporations that would come under the commission. He thought it might possibly take twenty years. He also urged that "enforcement breeds suspicion," and that every corporation "should lay its cards face up."

DOMESTIC

FOREIGN

The Rev. Bertrand M. Tappan, pastor of the American Methodist church in Rome, has purchased about six acres at one of the most beautiful locations near Rome to erect a great modern college, the highest intellectual, patriotic, moral and physical.

The French National Socialist congress at Amiens unanimously rejected the proposal that the party unite with the radicals, thus rejecting the famous pact which had been signed, however, that where the election of a socialist is considered impossible the socialist candidate may nearly approaching the socialist ideal.

France's national policy is to develop the utilization of cotton in Morocco so that the country shall not be so dependent on the United States for that product, according to Louis Barthou, foreign minister. In the course of a debate in the French Chamber of Deputies, M. Barthou suggested that a sum of \$10,000,000 should be devoted to this purpose yearly.

At a meeting of President Rodas and his cabinet, it was decided to order the immediate release of Federico Calvareso, former minister of finance, and a candidate for the presidency, and that students and several other prominent men who have been under arrest under political charges.

The Prussian academy of architecture declared unassailable the plans for the new German embassy at Washington drafted by the court architect, Ernst von Ihse. It also disapproved of the plans of the three winners of the competition called for the purpose by the government. The academy recommends a new competition restricted to the four architects.

PRESIDENT TO LIFT EMBARGO ON MUNITIONS

BOTH FRACTIONS OF MEXICANS TO BE PERMITTED TO PURCHASE ARMS IN U. S. BAN HAS SERVED TO HAMPER REBELS ONLY

Huerta Forces Have Been Able to Secure Necessary Supplies Abroad White Constitutionalist Get Only What They Could Smuggle

Washington, Feb. 4.—President Wilson has decided to lift the embargo on exportation of arms to Mexico. A proclamation under the authority of the congressional resolution of 1913, which will restore the status of the arms question to where both Huerta forces and constitutionalists may import arms from the United States, soon will be issued from the White House.

News of the action about to be taken by President Wilson became known through sources which have been confidentially advised of the administration's policy in Mexico. It also became known that the subject had been discussed at the cabinet meeting Tuesday.

Official Announcement Later. There were intimations that an official announcement of the president's decision would be coming from the White House later.

It is believed that President Wilson finally decided to raise the embargo on arms to Mexico, by restricting shipments of arms to Mexico, the United States was not really showing neutrality, which was the purpose of the embargo, but was, in fact, showing partiality, as the Huerta forces were unable to get large supplies from abroad while the constitutionalists were limited almost entirely to shipments from the United States, which would aid arms and ammunition practically only by smuggling.

World Aid in Ending War. It has been frequently represented to the administration during the progress of the Mexican revolution that if the United States would permit free shipments of arms to General Carranza, the constitutionalists would undertake to restore peace in Mexico by ending the Huerta government.

Constitutionalist agents in Washington learned of the development unofficially and declared that the end of the war is in sight.

For many weeks senators of the foreign relations committee have been urging President Wilson to permit the importation of arms to the belligerents in the hope that the war soon might be ended and peace restored.

Close to the president said all along that he would take such action as only one of the last reports of his Mexican policy preferred to the president, that it was the "moral pressure" and the "moral blockade," which has, so far, stopped the Huerta government from obtaining credit abroad, has only recently caused it to default on the interest of the Mexican public debt and has seen the army of the constitutionalists steadily marching on from victory to victory.

There is every reason to believe that, under the authority of the joint resolution of March 14, 1913, President Wilson will continue to exercise discretionary power in issuing permits for the exportation of arms to that they may not go to the hands of irresponsible persons.

CHARGE NANTUCKET CAPTAIN

Secretary Redfield Orders Investigation Relative to Collision Which Cost Lives of Forty-two

Washington, Feb. 4.—Secretary Redfield has directed that charges of negligence be preferred against Capt. Henry C. Stuart, commander of the Nantucket steamship, which collided with and sank the Old Dominion liner Monroe with a loss of forty-two lives off the Virginia coast last Friday.

The secretary announced that evidence brought out by the inspector's preliminary inquiry held on board the Nantucket while that vessel was making her way into Norfolk with the Monroe's survivors aboard, tends to show that there was negligence on the part of Captain Stuart.

No intimation was given as to the specific nature of the negligence to be charged against the Nantucket's skipper. The two vessels met in a dense fog early Friday morning and struck near the coast from Norfolk for New York and the Nantucket steamed southward from Boston for Norfolk.

The Nantucket drove her bow into the starboard side of the Monroe, causing her to sink within a few minutes.

BOARD TO GOVERN AIR RACE

San Francisco, Feb. 4.—Negotiations are under way for the creation of an air board, consisting of national commissioners from each of the countries on the route of the Panama-Pacific globe-circling aviation race.

This commission will be scientific and advisory and its duties will be to suggest the plan of route and other conditions, to make meteorological and scientific observations.

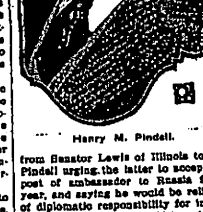
PINDELL REFUSES TO BE AMBASSADOR

PROF. ILLINOIS MAN DECLINES POST IN RUSSIA

Washington, Feb. 3.—Henry M. Pindell of Peoria, Ill., who recently was named and confirmed as ambassador to Russia, has declined the appointment, according to a letter to the president, made public at the White House.

Reason for Declining. Mr. Pindell wrote President Wilson that, although the senate had invested the controversy in connection with his appointment, he felt, nevertheless, that no controversy of any kind should surround the appointment of any ambassador, as it was able to be understood abroad.

The president, in a letter of regret accepted Mr. Pindell's resignation. Mr. Pindell's nomination grew out of the publication of what purported to be a letter



from Senator Lewis of Illinois to Mr. Pindell urging the latter to accept the post of ambassador to Russia for a year, and saying he would be relieved of diplomatic responsibility for important negotiations and could travel freely in Europe. A senate committee investigated the correspondence and recommended the confirmation of Mr. Pindell.

BARK HERRA WRECKED AND BUT FIVE SAVED

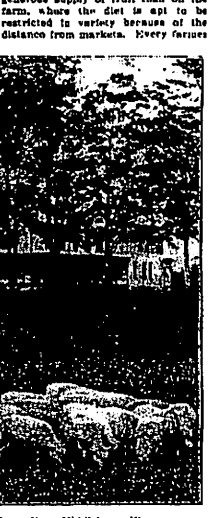

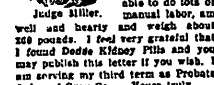

Agitation for each terminal marketing company began in Saskatchewan in 1903, where the Grain Growers' Association conceived the idea of investigating the Winnipeg Grain Exchange. A farmer was sent to Winnipeg, who after an investigation of three months, recommended the formation of a farmers' grain company which should get a seat on the Winnipeg Exchange, and go into the commission business.

In July, 1906, the first meeting of the shareholders was held in Winnipeg. A seat was purchased in the Winnipeg Grain Exchange for \$2,000 and also the company was out \$1,700 in debt, a line of credit was secured by joint signature of many farmers, and the company began business on the fifth of September, 1906.
